
Bristol Gate US Equity Fund LP (the "Partnership" and the "Fund")


Bristol Gate is a Toronto-based Investment Manager that combines fundamental analysis with data science to identify companies with the highest dividend growth over the next 12 months. Bristol Gate uses machine learning and other data science techniques in constructing portfolios aimed at reducing risk and improving returns while avoiding emotional bias in the investment process. Bristol Gate was founded in 2006 and is a privately owned company. The investment objective of the Fund is to achieve long-term growth of income and capital. The Partnership invests in 22 or fewer equities of publicly traded dividend-paying US companies that are constituents of the S&P500®. These companies are expected to generate dividend growth as determined by the Bristol Gate's proprietary methodology.

However, Bristol Gate's portfolio construction process differs materially from that of the benchmark and the securities selected for inclusion in the Partnership are not influenced by the composition of the benchmark. For example, the Partnership is a concentrated portfolio of approximately equally weighted dividend-paying equity securities, rebalanced quarterly whereas the benchmark is a broad stock index (including both dividend and non-dividend paying equities) that is market capitalization weighted. As such, Partnership performance deviations relative to the benchmark may be significant, particularly over shorter time periods. The Partnership has concentrated investments in a limited number of companies; as a result, a change in one security's value may have a more significant effect on the Partnership's value.

SPDR S&P 500[®] ETF Trust (SPY US) sourced from Bloomberg has been used as a proxy for the S&P 500[®] for the purpose of providing non-return based portfolio statistics and sector weightings in this factsheet.
